Pan-Canadian Select Molecule Price Initiative for generic drugs

Alberta Drug Benefit List prices effective April 29, 2022

The Pan-Canadian Select Molecule Price Initiative, established in 2013 by the Health Care Innovation Working Group of the Council of the Federation, achieves better value for generic drugs by leveraging the combined purchasing power of participating jurisdictions to obtain the lowest generic prices achieved to date in Canada.

Effective **April 29, 2022**, the following generic molecules have been selected for additional price reductions: alendronate, atenolol, bisoprolol, carvedilol, dutasteride, finasteride, risedronate and risperidone.

Through a Pan-Canadian Price Confirmation process, manufacturers have confirmed their ability to supply the drugs included in this initiative at the below price points to pharmacies in participating provinces and territories, including Alberta.

Notification of prices is being provided at this time to allow pharmacies, manufacturers and wholesalers adequate time to adjust inventories and manage stock. The previous higher price will be recognized until May 31, 2022.
