Importation of USA - Cortef 10 mg Tablet due to shortage

Due to the shortage of Cortef (hydrocortisone) 10 mg tablets in Canada, Health Canada has allowed the importation of Pfizer's US-labelled Cortef 10 mg Tablet. This medication has been added to Health Canada's List of Drugs for Exceptional Importation and Sale in Canada.

Please note: A temporary Product Identification Number has been assigned to Cortef 10 mg Tablets (PIN 09858155) effective as of July 12, 2022

US-labelled Cortef 10 mg tablets, manufactured by Pfizer Canada, contains the same active ingredient, dosage form and route of administration as the Canadian-labelled Cortef 10 mg tablets that were authorized and marketed for sale in Canada, but the products differ with respect to the packaging.

The differences in packaging between the US-labelled and Canadian authorized product are bolded in the table below:
