Enhanced website functionality accommodates manual drug claim submissions


Alberta Blue Cross is pleased to advise that, effective July 21, 2022, our secure website allows for the submission of the following manual claim types with service dates that are less than one year old:

- High-cost drug claim (with costs over \$9,999.99)
- 1976 drug claim (must be for group 19823 and have a valid eight-digit authorization number)

For claims submitted for review through the website, you will also have the ability to submit a claim reversal, and resubmission if applicable, should you identify an error with your original claim submission. Specific details on how to successfully submit claims can be found in our user guide. Successful submission of a manual claim does not guarantee the claim will be paid; Alberta Blue Cross will only pay for claims that comply with the plan member's applicable coverage.

NOTE: This new website functionality is not to be used for claims that can be direct billed through the Pride RT® POS system. Where applicable, it is only intended to replace the use of paper manual claim forms that are faxed to Alberta Blue Cross for processing.
