Removal of temporary benefits from the Alberta Drug Benefit List (ADBL)

Due to the shortage of Primaxin 500 mg/500 mg/Vial Injection (DIN 00717282) manufactured by Merck Canada Inc., Ran-Imipenem-Cilastatin 500 mg/500 mg/Vial Injection (DIN 02351706), manufactured by Ranbaxy Pharmaceuticals Canada Inc and Imipenem & Cilastatin 500 mg/500 mg/Vial Injection USP (DIN 02358344), manufactured by Sandoz Canada Inc. were added as temporary benefits for the *Alberta Drug Benefit List (ADBL)*.

Merck Canada Inc. has advised Alberta Blue Cross that the shortage of Primaxin 500 mg/500 mg/Vial Injection (DIN 00717282) has been resolved.

As a result, Ran-Imipenem-Cilastatin 500 mg/500 mg/Vial Injection (DIN 02351706) and Imipenem & Cilastatin 500 mg/500 mg/Vial Injection USP (DIN 02358344) will no longer be considered temporary benefits for the *ADBL* after **February 2, 2017**.
