Temporary benefit added to the Alberta Drug Benefit List (ADBL)

Due to the unavailability of Anafranil 50 mg Tablet (DIN 00402591), manufactured by AA Pharma Inc., Taro-Clomipramine 50 mg Capsule (DIN 02497514), manufactured by Taro Pharmaceuticals Inc., will be considered as a temporary benefit for the *Alberta Drug Benefit List (ADBL)*. These products will be added to the Critical Supply Product List effective **July 28, 2020**.

As of **July 28, 2020**, all claims for Taro-Clomipramine 50 mg Capsule (DIN 02497514) will be adjudicated to the price published in the most recent *Alberta Blue Cross Drug Price List (ABCDPL)* until further notice. If this situation continues to be a long-term matter, then this product is subject to the usual review process by the Expert Committee on Drug Evaluation and Therapeutics and must be approved by the Minister of Health for addition to the ADBL to remain as a benefit.

Product supply shortage addressed for Alberta Drug Benefit List (ADBL)

Alberta Blue Cross has been advised by Actavis Pharma Company and Pharmascience Inc. that the shortages for Act Buprenorphine/Naloxone 2 mg/0.5 mg Sublingual Tablet (DIN 02453908) and pms- Buprenorphine/Naloxone 2 mg/0.5 mg Sublingual Tablet (DIN 02424851) have been resolved. Due to the long-term nature of these shortages, a transition period will be applied, and as a result, the LCA price policy will be reapplied to the following grouping effective **September 8, 2020**. The following grouping was removed from the Critical Supply Product List **August 7, 2020**.
