Blood glucose test strip claims for Alberta Blue Cross employer-sponsored group and personal health plans and Alberta government-sponsored programs

Effective August 1, 2021, blood glucose test strips, brand specific Product Identification Numbers (PINs), as noted in the table below, were introduced for the adjudication of claims for Alberta government-sponsored programs.

Effective December 14, 2021, all Alberta Blue Cross employer-sponsored group and personal health plan drug programs will also utilize the brand specific PINs for blood glucose test strips. Pharmacies will need to use the appropriate PIN assigned to the specific brand of blood glucose test strip dispensed.

Payment eligibility

Effective December 14, 2021, the payment eligibility for all Alberta Blue Cross employer-sponsored group, personal health plan drug programs and Alberta government programs will be the cost of the product (drug cost) and upcharge. A dispensing fee is not an allowable cost for blood glucose test strips. Alberta Blue Cross administers many national employer-sponsored group plans, which allow out-of-province pharmacies across Canada to direct bill based upon the pricing structure in the jurisdiction that the claim is being made. Direct bill claims from pharmacy providers outside of Alberta, exceeding the allowable prices, upcharges or fees will not be rejected but may be reduced to the plan maximums. The plan members will be responsible for any additional charges.

Pharmacies must ensure the product claimed accurately reflects the product dispensed. It is important that accurate claims information is submitted to Alberta Blue Cross.

Miscellaneous blood glucose test strip PIN 00999955

As of December 14, 2021, claims will no longer be paid under PIN 00999955 for Alberta Blue Cross employer-sponsored group and personal health plan drug programs and Alberta government-sponsored programs.
