Please see the below thread which remains unanswered by any party. I am sure you are familiar with the current situation at Universal Ostrich Farms. However, in light of Premier Eby's recent stop in Japan, are you aware of the history of this farm for the last 5 ½ years? I am surprised at the absence of comment and action by your department in relation to clearly dangerous SARS-CoV-2 experimentation in an open-air farm in BC since 2020.

Your department locked down BC for a large portion of 2020 and 2021 over COVID. Please see the latest statement from Struthio Bio/Universal Ostrich Farm that further implicates Kyoto Prefectural University and UBC in uncontrolled and dangerous biohazardous activities in Canada by an Alberta company.

Can we see the export license for moving Biohazardous material (BL3) to Japan from Canada?

Struthio Bio/Universal Ostrich Farm statement

"We are part of collaborative research (Struthio Biosciences and Universal Ostrich Farm) that involves antigens and the collection of eggs on the farm, with the second part of the research occurring in an accredited university-based research facility in Japan. We are a real farm setting with exposure to all variables whereas controlled research activities are being conducted at the Japanese university."

Disinformation #4: Further, the current physical facilities at their location are not suitable for controlled research activities or trials.

Response: We are part of collaborative research (Struthio Biosciences and Universal Ostrich Farm) that involves antigens and the collection of eggs on the farm, with the second part of the research occurring in an accredited university-based research facility in Japan. We are a real farm setting with exposure to all variables whereas controlled research activities are being conducted at the Japanese university.

As for the claim that the farm's facilities are "not suitable" for research — that is a subjective opinion, not a regulatory ruling, and contradicts the fact that research was already underway in collaboration with a University and private sector experts. The farm isn't asking to run a Level 3 bio lab. It is a living herd being observed for natural immunity, not manipulated in a clinical trial. The CFIA's dismissal appears motivated not by scientific standards, but by bureaucratic control. CFIA seems to discredit research when it refused to review it.

In that update is an alarming email extract from January 4th, 2025 alleging to be from Dr. Yasuhiro Tsukamoto. In that extract he states that students and faculty members from Kyoto Prefectural University in Japan have been travelling to the farm in British Columbia, Canada where they have been injecting these ostriches with pathogens in a completely uncontrolled environment. Based on court filings and statements from Dr. Steven Pelech and farm owners, this appears to have been happening during the COVID pandemic where travel restrictions were significant.

What pathogens were being injected and where did they originate? Kyoto University? UBC? Health Canada?

Since the date of that letter there have been a large number of these birds that have died onsite. Dr. Tsukamoto has allegedly been injecting ostriches since 2020 with SARS-CoV-2 spike proteins. He has also been injecting ostriches with numerous highly infectious pathogens before and since that appear to include MERS, Zika, and even Ebola.

I must request an immediate response to the above and below.

Good afternoon,

I am sure you are aware of the escalating situation at Universal Ostrich Farms in BC.

As a retired police officer, familiar with biohazard containment, and resident of Alberta where Struthio Bio is

located, I was horrified to see Dr. Steven Pelech of UBC on social media this morning making the following statements.

“They [CFIA] say Universal Ostrich Farm has not substantiated their claims of scientific research. CFIA has not received any evidence of scientific research being done at the infected premises. And I note they're saying only, only at a specific premises.”

“Yes, they've coached that very, very carefully. First of all, they know because in my expert reports I actually provided them with the testing results from the summer of 2024 with our epitope mapping of the different antibody response to the different proteins in the virus from these birds. So. But that wasn't done on site.”

[00:05:25.80] - Steven Pelech

“That's why the way they've couched those words technically they haven't lied, but in fact they're giving a misrepresentation. But I think what they were referring to more specifically was in order to have an exemption from being culled in the first place, there was that little gap. The farm, the United Ostrich Farm was supposed to provide information, records that they had some genetic information on these birds. But the thing is, the farm started like almost 30 years ago. So those kind of records are not easy to come by because the original researchers that had that and they were involved in this with UBC at the time, but that whole program has been shut down. And once the programs are shut down, the records are destroyed because, because nobody's going to continue that work. So they weren't able to provide the documentation in that respect which the CFIA was looking for. But in terms of the COVID 19 research that was ongoing, it's clear that they were doing work with the, I guess it was university in Japan where they have a collaborator and they had, they had work for, even business plans for creating this new company. That was an already work underway where they've been injecting these birds with the, again the SARS CoV2 virus spike protein. So, I don't know where they can get this kind of statement. Clearly these birds are being used for research. They're not selling them, you know, for consumption.”

Through this interview and other information sources, I have confirmed that this farm has been allegedly experimenting with the SARS-CoV-2 spike protein and injecting this biohazardous material into the ostriches. Many have died since 2020. Dr Pelech confirms he has provided sworn testimony to that effect. As handling such a dangerous biohazardous material is limited to such agencies (including UBC) that are part of the [The Canadian Consortium of Academic Biosafety Level 3 \(CCABL3\) Laboratories](https://ccabl3.ca/) (<https://ccabl3.ca/>), I am concerned as to how the UBC could be part of allowing an unsecure open air farm run by unqualified persons involved in dangerous experimentation – for profit. Further, this farm has been running tours for the public and selling cosmetics and food products throughout the last 5 years, up to at least December 2024.

Note that in public statements and court filings, this farm (and their expert witness) have inferred that other experimental research with other pathogens has been ongoing at this location since 2020.

The fact that this farm has now become a camp with bouncy castles and candy floss to attract children is nothing less than horrifying. I can supply more information on my investigation into this matter as required.

This is in addition to the fact that these birds have also been infected with a unique and highly transmissible strain of Avian Flu (H5N1).

I look forward to an expedited response. I would also suggest that PHAC be notified of UBC's involvement in these activities either directly or through their agent, Dr. Pelech.
