But in terms of the COVID 19 research that was ongoing, it's clear that they were doing work with the, I guess it was university in Japan where they have a collaborator and they had, they had work for, even business plans for creating this new company. That was an already work underway where they've been injecting these birds with the, again the SARS CoV2 virus spike protein. So I don't know where they can get this kind of statement. well, you know, the other thing too to bear in mind is that we requested, right from the time that the court injunction to prevent the calling on February 1st, we requested the ability to test these birds, and that was completely denied. We even tried to have a motion go forward in the courts to allow me to test these birds. And again, in the pretrial for that motion, the judge, Judge Zinn, who ultimately presided over the case in April, basically he said there's no point. And the rationale behind it was that, yes, we accept. And I think even the experts that were in cross examination for this case, they all agreed that the birds probably have an immune response and they don't have the virus anymore and they don't actually pose a set. But that's irrelevant because the whole case hinged around what was known at the time they made the cull decision. And the CFAA policy is that if any bird is even suspected, never mind confirmed, with a test of having influenza, they can go in and call the entire herd, any birds that that bird would have been in contact with. But the policy that they apply at the CFIA is that if you have an H5 or an H7 test, these are again, the hemagglutinin protein on the surface of the virus with, you know, two separate strains have been linked with high pathogenicity avian influenza virus. If they have a positive PCR test, and that's sufficient. And so this is why like 41 minutes after they got the results, they immediately issued the call order. But the problem is the test that they're using, the PCR test, first of all, the PCR test can be very accurate and they can distinguish amongst various strains. So used properly, the PCR test is actually a very good test. But when you do it at cycle threshold numbers, we call these thermal cycles. The reason why the test is so powerful is because with each thermal cycle, you double the amount of genetic material. So you can increase the amount to a point where it's detectable. So they're using, and we don't know the exact number, but we know it's over 36 cycles. So that's. So imagine like to give you a sense, this is like hundreds of trillions of times of the amount of original genetic material that was there in the sample to begin with with these amplifications and the problem is once you start going to that level of amplifications, you have about a 90% plus false positive rate. So that means, you know, 10% of the time maybe it's accurate, but 90% of the time there was no virus there. Because every time you do the thermal cycle, you're actually the enzymes that are being used to increase the amount of genetic material. They make errors, they make mistakes and then those mistakes get amplified.

If you do, and it used to be three months, but for some reason with the more pathogenic virus now they, they change it to 28 days. So I don't understand how that works, but that's what they do. So if you don't have an outbreak within 28 days in the zone, then you, you have disease free status. If you do not do anything, you let the virus burn out, so to speak, then you have to wait a year before you can get that disease free status. Now that's, that's the guidelines from the World Organization for Animal Health. The CFAA has their own policy. So they basically have eradicated any outbreak. And I think the last I calculated there was somewhere over 537 outbreaks in the last few years of avian influenza where they've gone in and they've just wiped out the entire herd at the first signs of an infection.
