The Justice Ministry was desperate to meet me until the Chief of Staff realized he would be in personal jeopardy. The Chief Whip wanted to get me a personal meeting with the Chief of Edmonton Police until he realized it would compromise the Premier and Ministers.

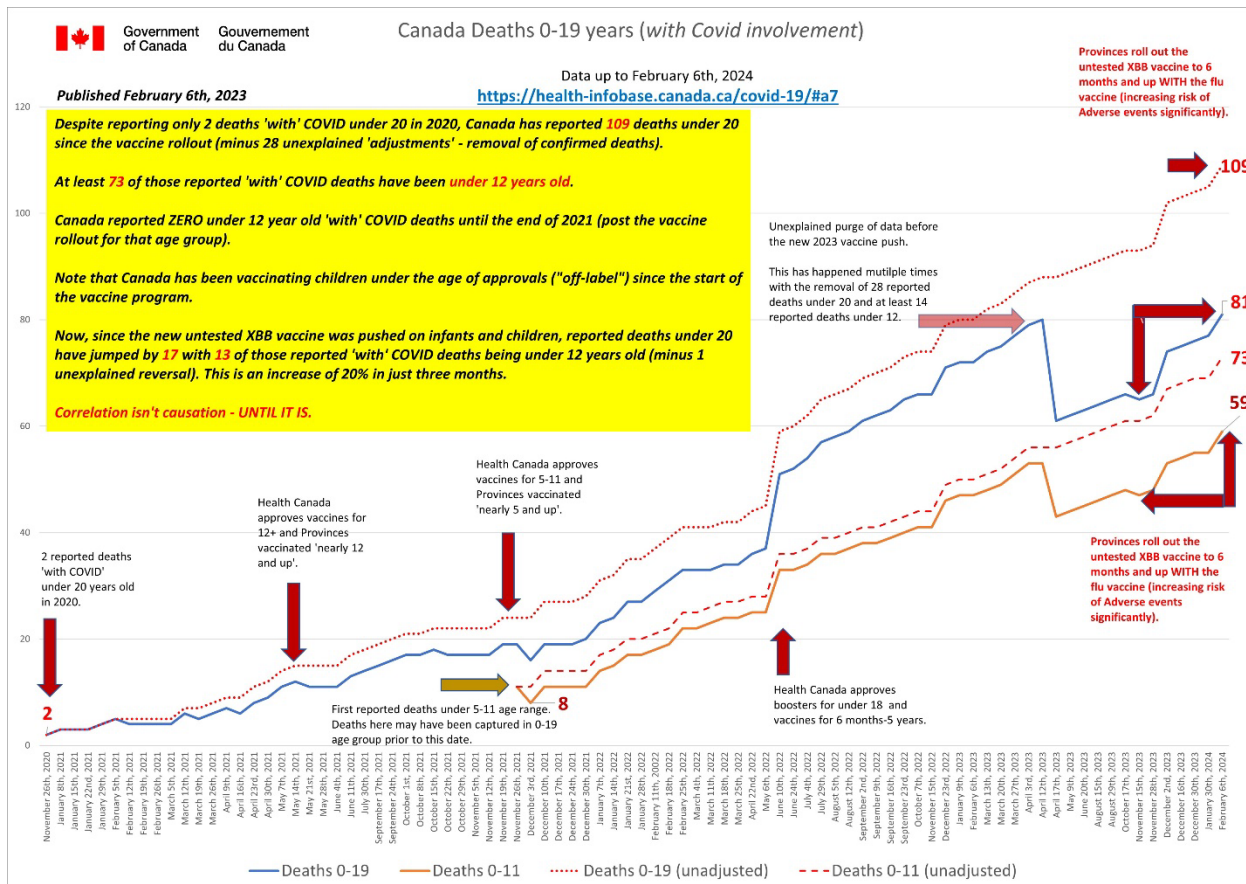

How many children are in these deaths (below)?

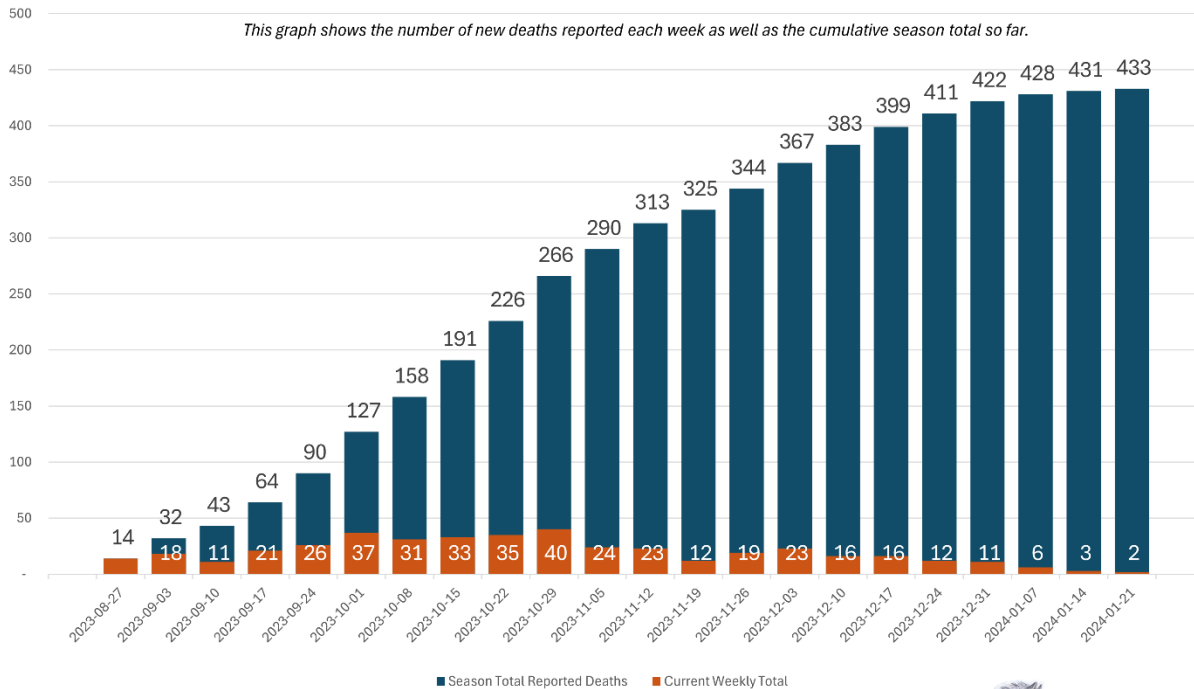

This graph shows the number of new deaths reported each week as well as the cumulative season total so far.



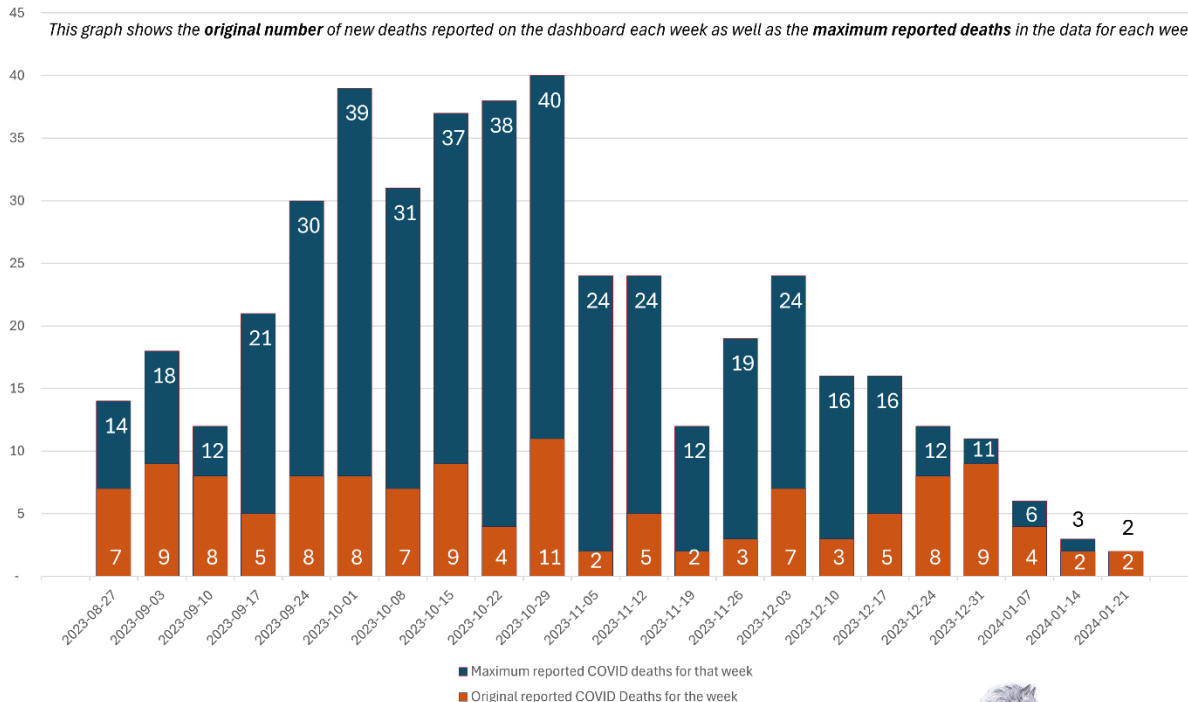

(2023-2024)

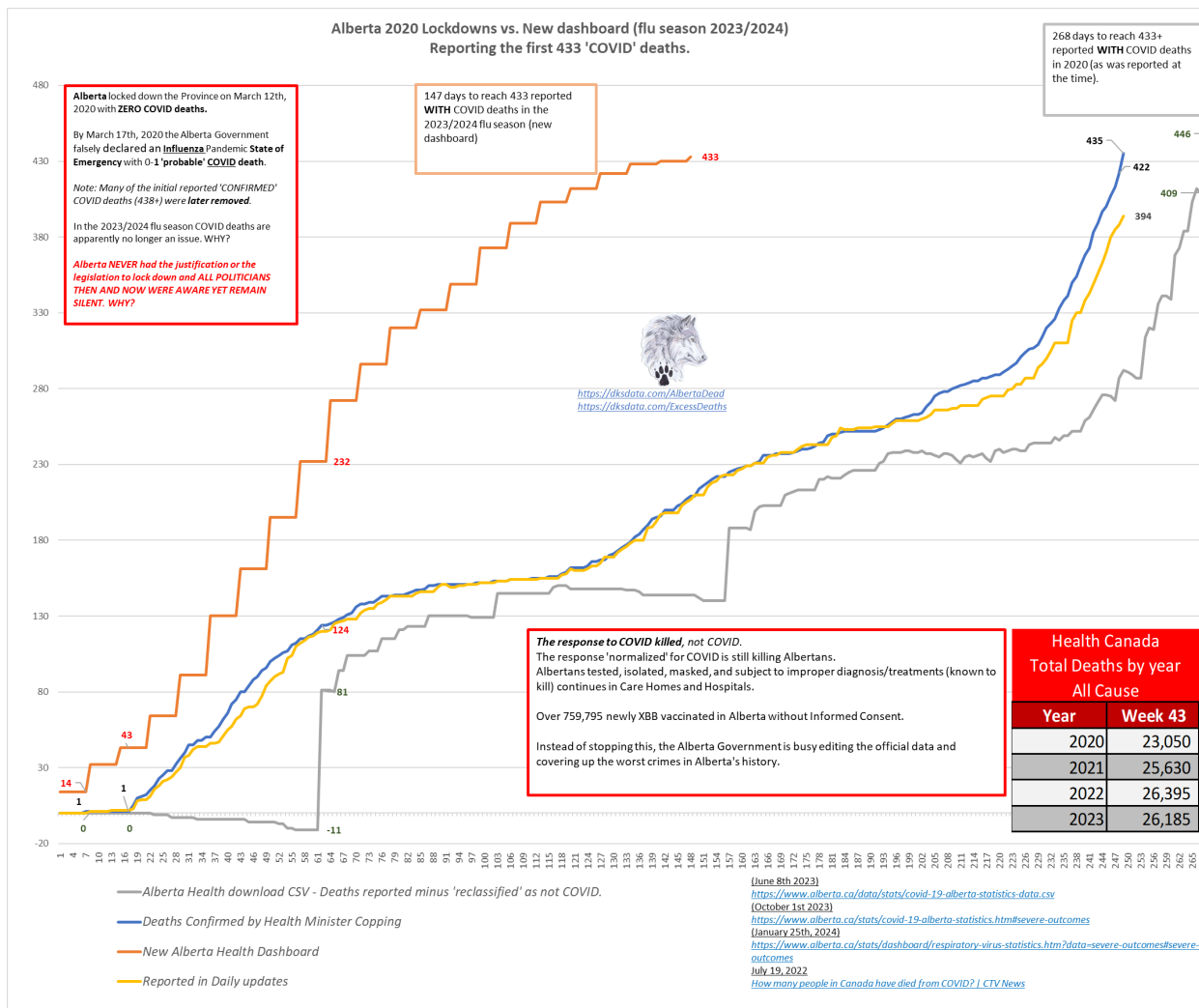
This graph shows the **original number** of new deaths reported on the dashboard each week as well as the **maximum reported deaths** in the data for each week.

More reported COVID deaths in half the time as 2020. Where is the panic now?



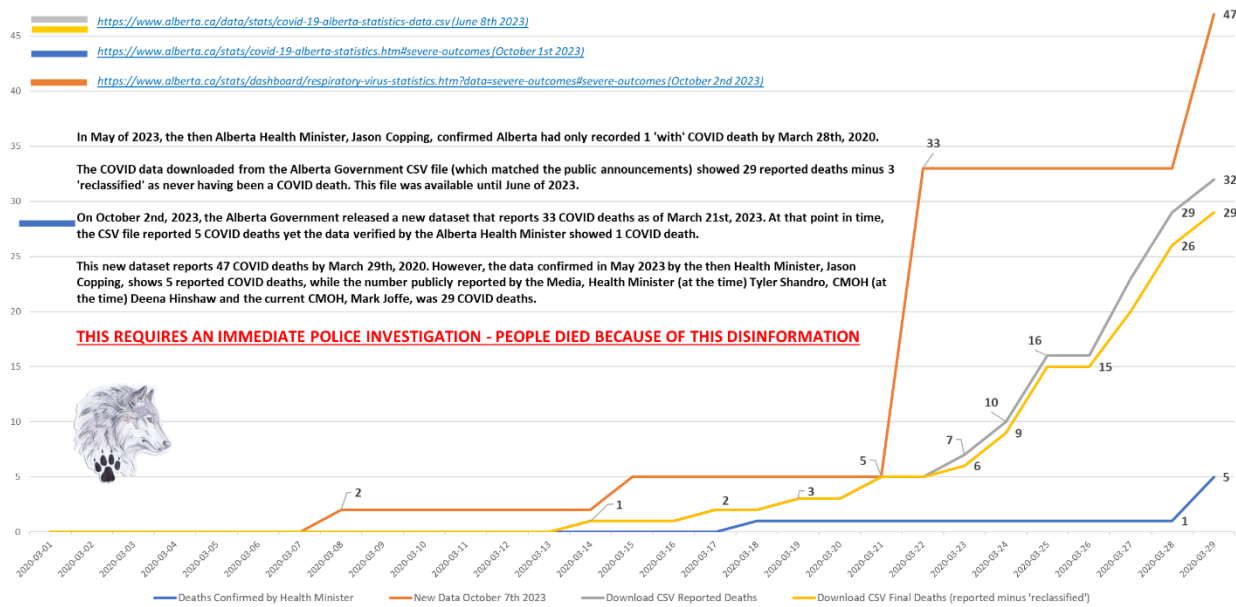
This government has retroactively changed COVID death data to add in almost 50 deaths in March 2020 that NEVER existed until the latest dashboard was launched in late 2023.
