Yesterday you stated publicly that;

“So this is the kind of approach you should probably expect from me, that I will always seek out contrarian voices”

Despite this public statement, your staff shut down the urgent arranged meeting in 2023 and have obstructed every effort to discuss these critical items impacting Albertans' lives daily.

September 29th, 2023 – the words of MLA Andrew Boitchenko.

"I just spoke to the **Chief of Staff [Justice Minister – KEITH PRIDGEN - JCCF LAWYER]** at their office. **They will be contacting you.** I gave them all your information. **I explained what you have, all the documents.** I said it takes about 2 hours to go through all the documents, and they really want to hear. **They are going to invite their chief policy advisor to have a conversation as well.** I said, you have **done the work that I think the army should have done.** They didn't give me a date, but I said it is urgent. **I showed them the texts that you sent where this is from our [the government's] own site [referring to the XBB vaccine pushed contrary to NAVI and CDC guidelines]."**

Alberta Justice Minister's Chief of Staff, Keith Pridgen, stopped this meeting from happening because he is the subject of the obstruction of justice. Ministers and others have compounded that since.

How can you make the statement about listening when you and your government have actively worked to suppress the information I have shown directly to MLA Boitchenko, Chief Whip Shane Getson, MLA Eric Bouchard and others more than a year ago? You have directly engaged in this suppression of speech by blocking me on social media to ensure I could not engage in any discourse on your official public account. Since you came to power more than 50% of infants under 1 year old have been given a COVID shot without informed consent. This is exponentially higher than almost anywhere else worldwide. POST the cancelled meeting to discuss the evidence and information shown to Chief Whip Shane Getson & others. Is this the reason?

UCP Chief Whip Shane Getson - January 30, 2024.

Me: "Do you know how many more people are **going to die** between now and May?"

Chief Whip: "Probably about **4,000**"

2024 Excess Deaths in Alberta by June 17, 2024 = 3,930. (over the 10 year pre-pandemic average: January 9, 2025 published data from Stats Canada).

"My job as the whip is to protect my Premier, my Party & my Government from [threats] foreign & domestic."

Note that Shane Getson, Eric Bouchard & Andrew Boitchenko and many others (including contributors to the Task Force report have seen the **unredacted** documents I have referenced.

I spoke to you at MLA Boitchenko's Town Hall on August 17th, 2024 about this. You were provided with a package of material at that event documenting some of this. I received no follow up from your office, Minister LaGrange or Minister Nixon though.

As a direct result of the changes made to 'outbreak' (COVID lockdown) protocols to create further restrictions in care homes immediately after that event, a resident at a care home, my wife and I were helping died. The family of Alice and I are still waiting on a response from your office or the appropriate ministers, but none comes. Now we see the expansion of AHS control within care homes with them taking money from residents' Trust accounts without authority and ongoing dangerous errors in Connect Care (under AHS control and not fit for purpose) that remain long after the system went live.

Alberta continues to have hundreds of active 'COVID' lockdowns in the province week after week and the highest rate of COVID shots in children in the world. All with the direct knowledge of you, your ministers and "political allies" and friends. Friends that includes EPS Chief of Police, Dale McFee who, with the help of his corporate lawyer, stopped the lawful investigation of these ongoing crimes. Is this why Chief McFee resigned before the end of his contract to be given a top government job by you? The timing is very concerning.

If you are true to your word, then I ask again for an urgent meeting as was promised in 2023 before you rolled out the XBB COVID shots to infants 6 months and up.

As a retired police officer and long time consultant to Alberta Justice and Law Enforcement, I have video, audio, documents, government data and witness statements to back all of this up. This includes documented statements by members of the Gary Davidson Task Force that contradict the report directly.

“The Alberta Pandemic Data Review Task Force examined the quality, use, interpretation and flow of information and data that informed Alberta’s COVID-19 pandemic response. This review builds on efforts already taken to enhance Alberta’s ability to respond to future public emergencies, while safeguarding the rights of Albertans and ensuring that public health measures are applied only in urgent and temporary situations. These actions include the introduction of amendments to Alberta’s Bill of Rights, amendments to the Public Health Amendment Act, and an ongoing review of regulated professions in the province.

Alberta’s government will continue to review the report and consider the task force recommendations, and it is important to note no policy decisions have been made in relation to it at this time.”

November 2022 – project initiated
March 2023 – HQCA provided project description and terms of reference.
Final Report Expected December 2023
Report date missed, and new date of May 2024 was expected.

All members received \$525 for their first 4 hours work and \$131 an hour PLUS EXPENSES thereafter.

Report delivered August 2024.

'Contributors' did not see the report until it was published publicly on January 25th, 2025, and so have not reviewed how their material was used. One contributor has already demanded his name be removed from the report.

The UCP government created this task force and invited the 'medical professionals'.

"Lisa Brake, a spokesperson for the HQCA, said the \$2-million budget flows through the council as an "administrative function only." She said the government provided a list of medical professionals for the HQCA to invite to the task force but otherwise had no involvement in the work or approach of the group."

"Alberta is paying task force members a government standard honorarium of \$525 up to and including four hours and \$131 for each additional hour. Members were required to sign a non-disclosure agreement and complete a conflict-of-interest declaration form that states "members are expected to act impartially."
