Second request for a response. Copy to ALL MLA's, MP's and Media.

In addition, can someone please explain why Alberta is rushing to rollout the XBB 1.5 vaccine to 6 months and up when it has not been tested and is for a variant that is at least two full strains distant (that effectively does not exist). I have already covered, in previous linked communications, the insanity/criminal acts regarding the rollout to 5-11 year olds in 2021 (and am still waiting for a response). To be booking appointments for booster shots of this new vaccine (or any COVID vaccine) to 6 months and up is criminal.

Also, why did we not receive an update on the COVID dashboard on Wednesday August 30th, 2023? In the previous update, it was initially posted that updates would be monthly and the next update would be August 30th, 2023. That in itself was an unacceptable 5 weeks delay, but even that has been missed. Now there is no indication of an update.

The missing (deleted) data that shows criminal intent still has no explanation and the "By Vaccine Status" available to Albertans until July 2022 (and published daily internally at AHS) has not been returned for public information.

As a result, the lack of informed consent will make every single vaccination given an aggravated assault. All of the above issues are the direct domain of the Health Minister and Premier of Alberta. There can be no further excuses for delays in responding or the interference by the UCP in MLA's meeting with their constituents when a meeting has been scheduled.

I am still waiting for a response from you or Andrew. It is clear that Andrew was not out of the province when he had a scheduled meeting with me I had waited almost 3 months for. He also failed to attend the Treaty Six event in the Town of Devon on Wednesday too.

To all attached, please consider this a formal demand for an explanation about the deceit and deliberate avoidance in attending to this MLA's duties to his constituents and the Indigenous community. Who is preventing Andrew from Doing His Job?

Note that this matter has become even more urgent now that there has been an 'outbreak' called in St. Micheal's Long Term Care where they have now implemented restrictions over and above anything seen during COVID. These very restrictions (laws at the time) were not only ignored by AHS, but approved through their audit process. At the same time, these processes (and others) were being used to 'mask' the deaths they caused. i.e. refusing access to DSP's unable to wear a mask while the staff did not wear masks in the communal areas for almost all of COVID (see links and previous communications for more details).

See the letter from the Director of St. Micheals as regards the lockdown of the facility in the below link. Note that the 14+ day 'outbreak' is in excess of the 5 day (vaccinated)/10 day (unvaccinated) isolation protocols published publicly (themselves a clear indication of the discrimination Premier Smith stated was unacceptable). As AHS has removed access to HCS-267, I am unable to verify what the exact protocols are that everyone is now expected to follow. However, information I have received internally shows that this letter identifies the current process including daily testing (now to be completed by the wholly owned subsidiary of AHS – Alberta Precision Labs).

Question: What exactly is more important than Andrew's constituents and the Indigenous community he is bound to represent, that he has to leave the province on government business for another month (having been unavailable since the start of June, travelling on government business)?

I have added everyone back on to this email that you removed and also added MLA Sharif Haji for comments. Mr. Haji did not abandon us but took the time to meet and listen to us and set up an action plan. Note that Mr. Haji represents the constituency of my disabled mother in law (a resident of Dickinsfield Care Home). I am her medical proxy and my wife is her PoA. Note that part of the discussion with Andrew related to the offences committed in that Care Home during COVID where I was not allowed onto the premises for 1,193 days due to my disability preventing me from wearing a mask.

This is one of the urgencies with the meeting with Andrew as masks did not leave this province on June 19th. Rather, they are part of an enhanced lockdown/outbreak protocol that was implemented that day requiring masks, goggles and daily testing if even two people show any symptoms of any respiratory illness in a 7 day period. How long before I, along with many other Albertans, will be locked out of Care Homes and hospitals again?

I am confused why this is coming from the UCP Caucus and not Andrew's official MLA office which has been the point of communication up to now. Additionally, I wonder why Andrew could not have made a quick cell phone call on as he does have my direct number, has called me before and he is aware of the importance and urgency of this meeting.

To be clear, I had an hour and a half meeting booked for tomorrow morning (August 23rd, 2023). This was originally scheduled to be all morning (up to 2 ½ hours) starting 9:30 am. It took a number of months and many emails and calls that went ignored (see below) before this meeting was finally confirmed on August 3rd, 2023. Andrew had spoken to me in late June and promised a call back on June 30th, 2023, to book a minimum 1 ½ hour meeting based on our discussion at that time. I never did get a return call at that time. I contacted the MLA's office in Devon and left multiple messages (only to be told later that the secretary for that office had not been retained, although messages were being picked up at the main office). I finally spoke to the assistant at the main office on August 3rd, 2023, who booked the meeting for August 23rd, 2023 at the Devon Office.

On Friday (August 18th, 2023), while I was at speaking at the Violet King Henry Plaza, Andrew left a message inviting me for lunch (12 noon) with minimal notice the next day (Saturday August 19th, 2023). Despite our agreement to meet, I never received the expected call at 12 noon. I called Andrew at 12:30 to ask what the delay was. Andrew then re arranged the meeting to 2:30pm without any real explanation for the further delay other than he had another meeting in Devon later. Andrew arrived late and then left at 3:45pm. This left us with an interrupted hour to speak, during which Andrew seemed more interested in my personal and professional history than the issues I had raised in my emails and calls.

Despite being invited for lunch, Andrew, you got up and left at 3:45pm and said, "Will you get this one, and I will get the next one" as you "had no cash". This seemed strange as our next meeting had been arranged to be at my house just north of Devon so there would be no one to get the next bill. In fact, the hospitality would be again at my expense at my own home. Is this normal practice to invite a constituent for lunch at a relatively expensive location, then leave them with the bill? Please note that it is the principle I am concerned with here more than the payment. But for many people (including myself), this would have been a significant and unexpected expense. This, combined with a lost day, a shorter than expected meeting and now a significant delay to a follow up leaves me with grave concerns about how seriously the UCP government is taking these issues when Andrew agreed they appeared criminal.

I was also told by Andrew that he would not be travelling now and so would be available anytime. Now I see the meeting is cancelled again with no practical notice despite the urgency of the matters raised. In fact, Andrew agreed to speak to the Justice Minister (among others) based on our short conversation (and the material already in his possession).

It appears that the UCP government is determined to bury these criminal matters and continue to put Albertans at serious risk to protect themselves. This is beyond unacceptable.

I have attached my previous email from yesterday to this email for reference and included links to all previous communications below.

I have included the Premier, Health Minister and Justice Minister for an immediate response to these matters.

As Andrew and you are all aware, Time is of the Essence. As Andrew is not available in a reasonable timeframe, and based on previous history and the comment "He will be out of province, for the next few weeks" may not be available in any timeframe, I am again formally requesting a meeting with the Premier, Justice Minister and Chiefs of Police as a matter of urgency.

Time is of the essence right now with the announced rollout of both the flu and new (untested) COVID vaccines starting in the coming weeks. The plan from Alberta Health is to do these on the same day which goes against the manufacturers' and NACI's guidelines. This is expected to be expanded to infants soon also.

Considering the known impacts and lack of informed consent we have seen in the care home and beyond, this is a serious concern.

And as Excess Deaths continue to rise here in Alberta (one of the worst in the country), the data needed by residents to make informed choices continues to be withheld or deleted from the government servers.
