Subject: UCP lying to constituents - MEDIA RELEASE and request for an urgent meeting.

Importance: High

Please consider this a formal complaint and request for media coverage regarding clearly malicious behaviour by the UCP government and a failure by the NDP (official opposition) to hold this government to account.

I had a scheduled meeting with my MLA on the morning of August 23rd, 2023. That meeting had been booked for three weeks. I had already waited months to confirm that appointment due to MLA Boitchenko travelling around the province with the Premier since he was elected (instead of meeting with his constituents). This meeting was arranged with MLA Boitchenko's official personal assistant at his main office.

On the evening of August 22nd, 2023, I received an email from the UCP stating my meeting had been cancelled as MLA Boitchenko would *"be out of province, for the next few weeks so we will be looking to reschedule for the end of September"*. Requests to clarify this (and that this was coming from a UCP paid person, not the MLA's personal assistant) were met with silence. I have emailed ministers, the Premier and more. All refuse to respond as they have done for a long time.

On August 25th, 2023, MLA Boitchenko posted images online from the Legislature building where he was in a meeting with the Indigenous Minister. This is not out of province.

On August 31st, 2023, MLA Boitchenko posted images online from a farm in his constituency (not far from my house) where he was in a meeting to present a plaque to a farming family. This is not out of province.

I sent these images by text to MLA Boitchenko. He finally responded this morning stating he was in Quebec City and then in Red Deer later in the month but could meet with me the week of September 18th, 2023 (another two weeks to flatten the resolve of constituents). I responded for clarification on why my meeting had been cancelled when MLA Boitchenko was clearly not out of the province for the last two weeks. I have not received a response. As you can imagine, I have zero faith this meeting will ever take place.

Why is the UCP interfering with MLA Boitchenko's meeting with a constituent? Is it because he stated to me that he believed the deletion of COVID data by this government constitutes a crime (which in my professional opinion is a reasonable assumption based on the evidence presented to him). Maybe it was due to the affidavit of evidence (from an AHS nurse) he saw relating to crimes committed during the vaccine rollout in 2021?

In the meantime, it is very likely I will be locked out of access to health care for myself and unable to act as medical proxy for my mother in law's who resides in a care home. This is due to the hidden restrictions and increased masking requirements that were implemented on June 19th, 2023 in this province. Despite my written medical exemption (supported by multiple doctors and specialists, directly responsible for my care), I was refused access to the care home for 1,193 days and refused urgent medical treatment on multiple occasions since 2020. I expect this discriminatory behaviour to continue. All of this is documented in prior communications, also ignored by this government and official opposition.

The OAG, AHS CEO, Capital Care Management and multiple MLA's have confirmed this is unacceptable, but the

government and official opposition refuse to act. And the media remains silent as they did when they knew Dr. Deena Hinshaw's memo was not "fake" as was reported by the Premier's office at the time. Note that I sent copies of the original memo to everyone in government the day after the memo was declared fake. I received no response.

If we cannot trust politicians to be honest about the simple things like meetings and hiring of Dr. Deena Hinshaw, how can we expect them to be honest about the escalating deaths in this province (and the world alike)?
