2022 and 2023 are the worst years on record for Albertans dying, eclipsing 2020 by a wide margin. And the silence from politicians and the media is palpable.

There have been more recorded COVID deaths in the last few months in Alberta (since the new dashboard was launched) than most of 2020. And yet there is SILENCE from BOTH political parties and the media. It has taken 134 days to reach 420 reported **WITH** COVID deaths in the 2023/2024 flu season (new dashboard). To reach that same number in 2020 took 268 days (as was reported at the time).

Alberta locked down the Province on March 12th, 2020 with **ZERO COVID deaths**. By March 17th, 2020, the Alberta Government falsely declared an **Influenza** Pandemic **State of Emergency** with 1 'probable' **COVID death**. *Note: Many of the initial reported 'CONFIRMED' COVID deaths (430+) were later removed.* In the 2023/2024 flu season COVID deaths are apparently no longer an issue. WHY?

As you are aware, I have documents, lab reports, witness statements, names, dates, recordings and more. These are evidence of criminal acts in this province that are being actively covered up by people in the government, health care, professional colleges and by lawyers in the so called 'freedom movement'. As a retired disabled police officer, the

deliberate and willful refusal to meet and review this material even after MLA Andrew Boitchenko has raised the alarm upon reviewing it personally is nothing less than criminal. You cannot ignore this and expect it to go away.

But now MLA Andrew Boitchenko and MLA Sharif Haji willfully ignore my calls and messages. Does the UCP and NDP really not care about an 80-year-old constituent who almost died before Christmas because of their lack of intervention?
