

Total respiratory outbreaks in the province of Alberta stand at 743 by location and 807 by illness. This means that in 64 locations, outbreaks have been declared for more than 1 respiratory illness. Covid takes the lead with 570, followed by a generic respiratory illness of 132. Outbreaks are most prevalent in Supportive Living, Long Term Care and Acute Care respectively. Remember every one of the outbreaks in these highly controlled facilities means that at LEAST two people in each location will be confined to their room, not by force of course, just by coercion, for a minimum of 10 days after which they will be allowed out of their room only if they wear a mask for a further 10 days. Just how effectively are all these COVID protocols working to keep everybody safe and well? One of the most alarming numbers in the outbreak list is the almost doubling of outbreaks in schools. Children already so negatively impacted by restrictions over the last almost four years... will they now be isolated in their homes because a couple of children in a class come down with a runny nose? At what point will we stop punishing these children, making them fearful of mild sickness which has been part and parcel of growing up from time immemorial. When will we allow them to just live again?

The province was locked down in 2020 for ONE probable death by the end of March. Since the new dashboard appeared in September this year, here we are with 245 new COVID deaths. But how many really died OF or even WITH COVID?? How long did it take to reach that number of reported COVID deaths in 2020? The 245 death number was reported September 6th, 2020 - SEVEN MONTHS after the State of Emergency was called. It gets worse though... since the new dashboard appeared, the Alberta government has added 298 deaths to the COVID total with some changes going back as far as 1299 days. Why would they be doing this? Because it has been pointed out to them that the narratives they've spun for the last 3 and a half years didn't match the data they were reporting, from the initial total needed for fearmongering and compliance to the manufactured risk benefit of the vaccine all the way through to the fraudulent Auditor General's report on care homes being used to justify the current protocols - to protect grandma to death. The Alberta government openly admits that they can't even tell you what people were hospitalized for prior to February 1st 2022. How can anyone possibly have trust in anything they say at this point? What we do know for sure though is that more people are sick than ever before, more people are dying than ever before and we have no answers from this or any government worldwide as to why. To be quite blunt, COVID PROTOCOLS KILL.

Government inquiries worldwide are a farce, based on the false premise that faster, harder and longer action could and should have been taken. Everything that has been said and done from inquiries to reports is based on the known false assumption that a COVID case was COVID, that a COVID hospitalization was COVID, that a COVID death was COVID. But from the very beginning and still to this day, governments and healthcare experts admit there were significant issues with how a COVID case was defined. Further, once a case became a hospitalization or death, the true reason for the hospitalization or death was obscured by the COVID label. For all of 2020, 21 and part of 22, everything was COVID even when it was known this was not true. Jason Kenney, former

Premier of Alberta, said in a Q&A session ‘Who cares about false positives?’ talking about the lack of reliability of PCR tests. Well, I guess every person restricted as a result CARES. Jason Leitch, National Clinical Director of the Scottish government described the PCR test as “a bit rubbish.” Dr. Yaffee, Associate Chief Medical Officer of the Ontario government stated, “you’ll get false positives almost half the time.” The Alberta COVID19 Scientific Advisory Group stated that for asymptomatic people “RT-PCR positive status cannot be used to infer potentially infectious status.” Dr. Deborah Birx in the US stated, “If someone dies **WITH** COVID19, we are counting that as a COVID death.” So pre-existing conditions or other co-morbidities that actually led to deaths were put down as COVID. How many heart attacks, strokes, cancers and more were hidden behind a COVID diagnosis? How many deaths were caused by the response from misuse of ventilators, forced isolation, lack of appropriate/early treatment like antibiotics, medical negligence, and protocols specifically implemented for COVID? Every one of these deaths was misclassified as COVID when the COVID response was the real cause.

Even when the outcome wasn’t death, every single misclassified case impacted many people. In the care homes through 2020 and beyond, lockdowns occurred when staff voluntarily tested asymptomatic. In my mother’s care home, time after time, 275 residents, hundreds of staff, family and friends were impacted for months on end as lockdown after lockdown occurred from just two unconnected asymptomatic cases. This triggered the testing of almost every resident and staff member. The global restrictions that followed devastated everyone involved. This policy of just two unconnected asymptomatic cases locking down part or all a care home continues to this day. For Aspen House in Morinville, this policy has denied access to anyone who isn’t masked, wearing a faceshield and following the mandatory sanitization requirements. Now think about how many residents in these facilities across the country and the world will continue to suffer and die from protocols proven to be deadly and built on a foundation of lies?

In Alberta alone, as I said at the start, there are currently 743 active outbreaks impacting thousands of Albertans. The longer we fail to get to the root cause of this ongoing chaos, the longer we deny the reality of what got us here, the longer we maintain this lie, the longer people will suffer and die. The government made it clear from the start that they were not responding to a crisis. They were manufacturing a crisis in their response. Every inquiry, every report, every statement we have seen fails to address two things: the root cause and the fact that none of this has ended. All they have proposed is a flawed plan on how to do this even worse next time around in the form of focused protection, ensuring the untimely demise of sections of society considered surplus to requirements. The UK COVID Inquiry is slated to last five years. We don’t have five years. Time is Up.
