

Politicians, lawyers and more have everything to gain from a continuing manufactured COVID crisis. If you don't understand by now that left or right of the aisle, they're all in this together, you have not been paying attention. If you think an inquiry, a review, a new political face or a freedom fighter will get to the truth or end this, you are also sadly mistaken. If you think this is over, that whether you took that shot or not gives you the upper hand, that we should just move on, understand that you are digging a mass grave. Ignorance and apathy, not any virus, will be the death of us all.

This week saw the release of Preston Manning's Public Health Emergencies Governance Review Panel's Final Report on the COVID response. Quite the mouthful and no value to any of us. Even with an admission of negligence on so many levels, it provides the government with a detailed defence that they acted in good faith. That is the furthest thing from the truth. We need a full investigation that starts with the fact that there was never the evidence to call a State of Emergency which was enacted illegally for a fake flu pandemic (look up Tyler Shandro's Ministerial Order 608/2020 and Order in Council 080/2020). Start here and every action from that point on is criminal! Start here and the entire COVID narrative falls apart. There was NEVER the evidence worldwide to call a State of Emergency. The Manning report is nothing more than cover for the government. This report is an endorsement of dictates now enshrined in law that will come back to haunt us all. It is a carte blanche free pass for future governments to exact any and all measures in response to what is widely deemed an emergency in the future. Without an investigation that lays bare a litany of data manipulation to mislead the public, a blatant fear campaign with incentivization, coercion and uninformed consent pushing every medical decision, this insanity continues ad infinitum worldwide. Without a full investigation, spearheaded NOT by the foxes in the henhouse but by trained forensic officers, this never ends. Governments know this. All those who are promoting, propagating and profiting from these lies know this. Those of us watching them know this. And our elderly and our children, legacies of the past and our future, those who have had no voice or choice in what has been forced upon them will continue to pay the ultimate price. Shame on you all and may God have no mercy on your souls.

In the Manning report, there was no analysis of what constituted a case, hospitalization or death. No real review of the CMOH and Ministerial Orders. What the report does do though is create more jobs for the boys such as Chief Scientific Officer (because we need another expert), more power for bureaucrats at the top – all with no accountability. There was nothing on the crisis that remains in care homes save to say it was covered in the Auditor General's report, another whitewashing of the truth based on false data. David has covered this in detail and sent his findings to this UCP government after its release. The Manning report amounts to pages of excuses, long words and legal jargon to again keep Albertans in the dark, to make it appear that lessons have been learned in a pitiful attempt to justify 2 million taxpayer dollars to line the pockets of half a dozen of Danielle Smith's political allies. Where is the exposure of crimes from the start from their predecessors, actions which are now being carried over with this government? Why the deliberate attempt to cover it all up?

What the report did acknowledge was the devastating impacts of school closures and lockdowns, something the minority of us screamed about from the start. Little comfort for what the report admits will be millions of dollars required for our children impacted educationally and beyond from the fallout. There is no discussion of harm suffered by children from isolation recommendations including from extended family, friends and their extra-curricular activities. What has been wrought upon children goes far beyond educational deprivation extending into all manner of medical interventions, culminating in shots without informed consent. How many more years before this is acknowledged let alone addressed? For many, it will be too late. The report also sets out standards for the treatment and schooling of children under future emergency conditions. There is a lengthy section on the protection of rights and freedoms, all of which the report states can be suspended in an emergency. This entire section is nothing more than lip service and will effectively remain unchanged. Cold comfort for countless people who were coerced into medical treatments to keep their jobs or who lost their jobs for non-compliance. More empty promises to try and pacify those with questions. Do you really think this has gone away? Worse, it is still in play, an operation now performed by stealth.

In short, the report states it is not an inquiry. It focuses only on 2020-2022 on the mistaken assumption that this is all over when nothing could be further from the truth. Every chapter of the report includes a rider that essentially states that in any emergency, the document and its recommendations are effectively moot. It doffs its cap at medical science, does not apportion blame at any healthcare practitioners, its only aim is to better prepare for the next emergency. This is

a firewall for continuing government tyranny under the guise of restructuring healthcare for the greater good. In the process, critical evidence of COVID crimes in the form of manipulated/deleted historical data will be buried along with the bodies. It ensures Jason Kenney, Danielle Smith and all around them are protected with recommendations which will never come to pass. And while we procrastinate, wait for someone to save us, Albertans are being herded to an early grave. The timing of the release of this report is another perfect distraction from rising excess deaths and all that this government is currently still pushing - testing, masking, vaccination and isolation. All this is still there in Alberta Health's most recent documentation and new AHS appointments for those who care - or dare - to look. In short, if we do not challenge these lies, if we just go on in ignorance with our lives, there is only one outcome - we will continue to be victimized and terrorized until we die. Every time I look into the eyes of my grandchildren and my mother, I know I cannot and will never accept that.

I visited with a practising family physician yesterday. She made the fatal mistake of asking how things were going. She listened with genuine interest to my tirade about the continued mistreatment of residents in care homes due to respiratory protocols. I described the prolonged periods of isolation enforced on residents for two "cases", the masking of residents - never enforced before now - and the active discouraging of visitation by caregivers for support in an outbreak. She shook her head. She said only GI outbreaks were a cause for real concern and action. She noted that what all this really boils down to is Informed Consent. I told her that that had not been provided to the public at large since 2020. I let her know that David and I have a meeting with Aileen Wong, CEO for Capital Care, right after we leave here today to discuss all this and more. She wished me luck. I know there are many more healthcare professionals like her who know what is happening is beyond wrong. Few will go public with what they say privately. So it is left for the few of us to fight for the many. One day, there will be a reckoning, a Day of Judgment for this. How many will have no regrets, face no recrimination, and find themselves on the right side of history?
