I am a retired teacher, a mother of two wonderful daughters and Nana to two beautiful girls. They are my life. And I would give my life to protect them. What good parent or grandparent wouldn't do the same? If there is one thing I've learned the hard way from 2020 on, it is to question everyone and everything claiming to have our children's welfare at heart. Our greatest responsibility is to guard those who have no voice and no choice.

This week was the Million March for Children. Is it really for children? Is it a grassroots movement? Who are the leaders, new faces and old? Why has this catapulted into the public arena right now, just after schools have gone back into session? How is it that this supposedly organic movement already has merchandise, T-shirts, hoodies, professional websites, familiar freedom group flyers and is soliciting donations to their "noble" scheme? Their word, not mine. Why do we see the same freedom faces leading the charge as we did with the convoy back in 2021? What happened to the millions donated to that cause by the way? Is anyone concerned that now we have two sides with irreconcilable differences pitted against each other, both claiming to be protecting children but by the very nature of their arguments and actions they are actively putting children in harm's way? Why the outrage NOW when the SOGI policy was launched in Albertan schools 6 years ago, in BC 7 years ago and when the Vancouver School Board first implemented a stand-alone Sexual Orientation and Gender Identity policy back in 2004? Do you have the answers to all these questions? Parents, if you aren't putting both sides in this powder keg masquerading as protecting all children under the microscope, then you are doing the greatest disservice to those you have a duty to protect. We tell our children they must do their homework. Have we done ours? Because following along with either side means you're being played like a pawn on a political chessboard. don't understand that this is by design, that they are being manipulated and all children will be the victims of this, THEY are their child's worst enemy. Look at the last few years! Children needed a voice when they were locked out of school for three months in 2020, forced into isolation at home and into learning online. Children needed a voice when they were forced to mask continuously to return to school. Children needed a voice when they were forced to be tested, masked and vaccinated for their extra-curricular activities. All this put children actively in harm's way but how many actuaaly spoke up in their defence? But all this is conveniently forgotten in a Million March for Children event that was pre-planned worldwide to distract and divide. It is a sham and a scam. And politicians? Notley picked a side and claims she stands for all children's human rights. And yet only mentioned the small number who were politically correct for her. What was Danielle Smith's response? She played politics too telling both sides to play nice. How is that action from either leader when children were the focus of this event? The Million March organizers broadcast ahead of time for parents to remove their children from school and bring them to a protest with content that was extremely sensitive and not something children should be exposed to.
